Subject: Student Insurance Renewal

Respected Sir,

1. Since 2018 - 2019, students of this college were provided insurance cover. 50 % of the premium cost was borne by the college and 50 % was borne by the student.
2. Last year Students had paid Rs. 3500/- as premium and an equal amount was paid by the college per student. *Total amount paid was Rs 10,19,520/-*
3. Renewal of policy is due on 7th July. Owing to increased claims, premium amount per student is expected to increase.
4. In view of expected rise in premium, students were informed that the burden of increased premium will have to be borne by them.
5. 181 students out of 184 students who were insured have written and given that they do not wish to continue student insurance
6. Students have also been informed that, In case insurance is discontinued, they will have to bear the cost of hospitalizations in future.
7. At present we are facing several difficulties in getting students to pay hospital bills in event when the insurance claim is rejected.

Kindly advice whether quotations for renewal of insurance should be sought or Student insurance should be discontinued.
